



Information on short-term frequency use with FIS Cross-Country World Cup

Under section 55 of the Telecommunications Act (TKG) each use of frequencies in Germany requires prior assignment. Unless a general frequency assignment has been issued, the Federal Network Agency for Electricity, Gas, Telecommunications, Post and Railway makes individual assignments. Where frequencies are intended to be used for a short time only, eg for car races, sports events, concerts and trade fairs, short-term assignments will be issued based on a simplified procedure. For short-term frequency assignments the following data is required

Address of applicant / company name, telephone, fax number, e-mail	address for invoice (if different),
Name of contact person on location, mobile number	event for which the frequencies are required
coverage area / locations of use	Equipment location
duration of use	

tuning range of equipment	wanted frequency (MHz)
occupied bandwidth (MHz or kHz)	Max. transmitter output power (W / dBW)
Max. antenna gain (dB)	type of link (ground-ground, ground-air, air-ground, satellite)
Number of equipment	Type of equipment (microphones, in ear, camera link, telemetry, communication,...)

Short-term assignments are made for up to 30 separate and/or consecutive days of use at one location/site. These days must fall within a period of six months from the first day of use. The frequency assignment may be extended for up to 30 additional days, subject to a fee. Short-term assignments are always made for a specific event or location.

In accordance with section 142(1) of the TKG in conjunction with the Frequency Fee Ordinance (FGebV), a fee is charged for each channel assigned. For temporary operation of a channel (up to 30 days at a location) a fee of € 130.00, and for each additional channel a fee of € 50 is payable.

If you use frequencies without a valid frequency assignment, under Section 149 of the Telecommunications Act this may be punishable by a fine not exceeding € 500,000.

Applicants are requested to submit their applications not later than 4 weeks prior to the intended start of use. As regards applications received at a later date - especially if the frequency is intended to be used in the vicinity of a border to a neighbouring country - timely frequency assignment cannot be guaranteed.

Applications for short-term frequency use have to be submitted to the following Bundesnetzagentur office :

Wenn keine gültige Frequenzzuteilung vorliegt, muss für die Frequenzen, die genutzt werden sollen, **vor der Inbetriebnahme** eine Frequenzzuteilung beantragt werden.

Der Betrieb von Funkgeräten ohne Frequenzzuteilung verstößt gegen das Telekommunikationsgesetz und stellt eine Ordnungswidrigkeit dar, die entsprechend geahndet wird.



Frequency usage during the World Cup Cross-Country

All the frequencies used for the 2009 World Cup Cross-Country by the participating nations and media representatives must be coordinated by the *Bundesnetzagentur*, or Federal Network Agency. In the absence of a valid frequency assignment, you must apply for assignment of the frequencies you are intending to use, **before doing so**.

Please note that operating radio equipment without frequency assignment constitutes a breach of the German Telecommunications Act and an administrative offence which is punishable by fine.

Toute utilisation de fréquence pendant le Championnat du Monde de cyclisme sur route 2009 par les nations participantes et les représentants des medias doit être coordonnée par l'Agence fédérale réseaux (Bundesnetzagentur). A défaut d'une assignation de fréquence valide une demande d'assignation des fréquences prévues pour utilisation doit être posée **avant la mise en service**.

L'exploitation d'appareils radioélectriques sans assignation de fréquence préalable est une violation de la Loi sur les télécommunications et constitue une infraction qui peut être frappée d'une amende.
